Its transgressive character, however, was overcome by the events of October 18, 2019, in Chile, which even led the government to declare a state of constitutional exception, that is, a temporary suspension of the rule of law. Thus, both this project and the political context that determined it, open the same question: to what extent can a temporary intervention have permanent consequences?




Everything would end abruptly on October 18th, the day of the party. That night, President Piñera established, through the signing of Supreme Decree No. 472, a State of Constitutional Emergency. Thus, under the mandate of the General of Division Javier Iturriaga del Campo, freedom of assembly and transportation were restricted in the provinces of Santiago and Chacabuco. Less than fifty people arrived at the party. On Instagram, they watched the subway stations burn, waiting for the impending curfew. ARQ






